The Platinum Mastercard Introductory APR for balance transfers and cash advances will apply to transactions posted to your account during the first 12 months following the opening of your account. Any existing Texas Trust Credit Union Ioan or credit card accounts are not eligible for the Introductory APR for balance transfers.

Loss of Introductory APR:

We may end your Introductory APR for purchases, balance transfers and cash advances and apply the prevailing nonintroductory APR if you are 60 days late in making a payment.
